NEW STUDENT APPLICATION FEE: (\$125) Required upon application and is non-refundable.

ENROLLMENT/RE-ENROLLMENT FEE: (\$300) Required upon enrollment and is non-refundable. Max \$600/family.

ADDITIONAL REQUIRED PAYMENTS:

- Tuition Deposit Due January 1, 2025 NON-REFUNDABLE

 If you enroll after January 1, 2025, the tuition deposit is due at the time of your enrollment. This payment is nonrefundable and is the first of ten payments if you choose our Tuition Payment Plan (reference Payment Options section).
- Elementary Curriculum Fee (\$600) Due August 1, 2025 NON-REFUNDABLE
 The Curriculum Fee covers costs associated with curriculum upgrades, consumable supplies, enrichment programming, technology upgrades, school events, and field trips.

TUITION ASSISTANCE:

Discounts: Families may receive only one of the following discounts, if eligible.

- <u>Sibling Discount</u> The oldest child's tuition is at the full tuition price. Then each subsequent child/sibling will receive a 5% discount on their tuition.
- <u>First Presbyterian Church Discount</u> If you are a member of the First Presbyterian Church, you are eligible for a 5% discount on *each* child's tuition.

Scholarships:

- <u>State Scholarship Programs</u> SPPS accepts the Family Empowerment Scholarship for Students with Unique Abilities for students 3 and older through the state of Florida. Visit https://www.stepupforstudents.org to find out if you are eligible.
- <u>Military Childcare Fee Assistance</u> SPPS accepts funding available to active duty military service members to offset childcare costs. Program requirements and eligibility are determined via the National Military Family Association.
- <u>St. Petersburg Primary School's Scholarship Program</u> Our goal is to provide a faith-based early childhood education to children whose families cannot afford the full tuition to attend SPPS. PAYMENT OPTIONS: We accept credit cards, debit cards or ACH payments. All payments must be made through FACTS

One-Time Yearly Payment

Paying as a one-time yearly payment can be set up in FACTS at the time of enrollment. Tuition is refundable on a case-by-case basis dependent on the date of withdrawal. Choosing the yearly payment requires a \$25 FACTS processing fee at the time of enrollment.

• Tuition Payment Plan

The Tuition Payment Plan splits tuition into 10 equal payments. <u>Each payment is non-refundable</u>. Choosing the payment plan requires a \$55 FACTS processing fee at the time of enrollment. Please see below for the payment plan schedule.
